LOCATION:

Miller Ranch

DIRECTIONS:

Halfway between Madras and Prineville, OR
From Madras: From Hwy 97 traveling south, go left at the south end of Madras, onto SE Hwy 26 (Madras-Prineville Hwy). Travel 11.5 miles to ride camp, on the left.

From Hwy 97, traveling north: in Terrebonne, turn right onto Smith Rock Way, go approximately 5.5 miles, turn left onto Lone Pine Rd, go approximately 6 miles to SE Hwy 26, turn left, go 2 miles, turn right onto driveway to ride camp.
Signs will be out on Hwy 26.
