# RIDE THE OLDEST ENDURANCE EVENT IN THE PNW!

AERC SANCTIONED - 30, 50, INTRODUCTORY TRAIL RIDE

**TRAILS:** One 30 mile loop with an out check, 50s have another 20 mile loop. Forested single track and dirt two-track, some gravel, very little repeat trail. Gentle grades, shallow water crossings, gorgeous views of the Cascades, lots of shade, great footing but some rocky sections. No cows and no gates! GPS trail routes will be posted. Jala Nuefeld will be taking photos!

**RIDE CAMP:** Sisters Cow Camp is less than 5 miles from the town of Sisters. Horse water provided, bring human water. **CWSF hay required.** "Zero trace" campsites (manure bin on site). Parking restrictions, attendant will direct. Fire restrictions enforced. **NO LOOSE DOGS!**

**ENTRY FEES:** Trail ride \$35 / 30 & 50 \$110, additional \$10 fee if not preregistered by July 25th. **Save \$20 on 30 or 50 if you prepay by July 1st (refund to those unable to attend).** Add \$15 if not an AERC member (except for trail ride). Discounts (one discount per rider): Reciprocal ride manager 50% (one per ride), PNER member \$5 off fee. Juniors ride free. Entry fee includes dinner (catered by Longboard Louie's), additional meals for \$10.

**AWARDS:** Awards will be presented after dinner Saturday evening as part of our Ocho de Agosto party!! Bring a desert to share and soak up the party atmosphere.

**RULES:** All AERC, PNER, and USFS rules apply. **Helmets required for all riders. No electric fencing allowed for horse containment.**
